Thank you for your interest in being a vendor at the Shavano Park's Winter Wonderland and Tree Lighting Event. For yours and everyone's safety and enjoyment, please adhere to the following:

1. Spaces will be assigned. Vendor area will be located on grassy areas around City Hall (except for food service vendors).
2. Vendor must provide own tables, chairs, tents, generators, and other equipment.
3. No flammable items except for generators or small open flames (e.g. candles).
4. No signs except in your booth area.
5. No vehicles allowed in vendor area after 1:00p.m. All vehicles must be parked in designated parking areas.
6. If selling food items, vendor must have your Health Certificate or copy at the event.
7. The event will end with the tree lighting around dusk, at which time you may start to break down your booth. Vehicles will only be allowed to be driven close to your booth AFTERWARDS. Vendors should then remove all boxes / supplies from the area
8. To reserve a space / slot – complete the registration sheet and return to Shavano Park City Hall for space assignment.

The City will not guarantee number of people attending the event. However, this event has been well received and we do expect a large turnout. We are excited for your participation and hope you enjoy the event.
